THE EMPLOYMENT OF CHILDREN (AMENDMENT) ACT 2011 (X of 2011)

[2nd May, 2011]

An Act

further to amend the Employment of Children Act, 1991.

Preamble.— Whereas it is expedient further to amend the Employment of Children Act, 1991 (V of 1991), for purposes hereinafter appearing;

It is enacted as follows:-

- **1. Short title and commencement**.— (1) This Act may be cited as the Employment of Children (Amendment) Act, 2011.
 - (2) It shall come into force at once.
- **2. Amendment in section 1 of Act V of 1991**.— In the Employment of Children Act, 1991 (V of 1991), hereinafter referred to as the said Act, in section 1, in sub-section (2), for the word "Pakistan", the words "the Punjab" shall be substituted.
- 3. Amendment in section 2 of Act V of 1991.— In the said Act, in section 2:
 - (a) for clause (ii), the following shall be substituted:"(ii) "Government" means Government of the Punjab;" and
 - (b) in clause (ix), for the words "Federal Government or the Provincial Government concerned", the word "Government" shall be substituted.
- **4. Amendment in section 4 of Act V of 1991**.— In the said Act, in section 4, the word "Federal" shall be omitted.
- **5.** Amendment in section 5 of Act V of 1991.— In the said Act, in section 5, in sub-section (1)—
 - (a) the word "Federal" wherever occurs, shall be omitted; and
 - (b) for the word "National" wherever occurs, the word "Punjab" shall be substituted.
- **6. Amendment in section 13 of Act V of 1991**.— In the said Act, in section 13, in sub-section (1), the word "appropriate" shall be omitted.
- **7. Amendment in section 17 of Act V of 1991**.— In the said Act, in section 17, the word "appropriate" shall be omitted.
- **8.** Amendment in section 18 of Act V of 1991.— In the said Act, in section 18, the word "appropriate" shall be omitted.
- **9. Amendment in section 19 of Act V of 1991**.— In the said Act, in section 19, the words "the Sindh Children Act, 1955" shall be omitted.
- 10. Amendment in section 20 of Act V of 1991.— In the said Act, in section 20:
 - (a) in sub-section (1), the word "Federal" shall be omitted; and
 - (b) sub-section (2) shall be omitted.
